Item No.1

Consideration of proposals for hosting the annual meeting of the Board of

Directors in 2012.

(Carried over from previous Board meeting).

Provincial Mohtasib (Ombudsman) Sindh, Pakistan had offered to host the next

annual meeting of the BoD in 2012 at Karachi, Pakistan. The Board in its meeting

held on 5th December 2011 decided that the new Board of Directors may further

discuss the issue in its meeting and decide accordingly. In the meanwhile

Commissioner for Human Rights (Ombudsman) of the Republic of Azerbaijan

offered to host the next meeting of the BoD in Azerbaijan in 2012.

## **Decision:**

The newly elected Board of Directors accepted with thanks, the offer of the Commissioner for Human Rights (Ombudsman) of the Republic of Azerbaijan to host the next meeting of the BoD in Azerbaijan in June 2012. The exact timing would be left to the convenience of the host.

### Item No. 2.

Consideration of working paper prepared by the General Inspection Organization, Islamic Republic of Iran, on establishment of academy and office of cultural group.

(Carried over from 11<sup>th</sup> annual meeting of the B.O.D)

On directions of the BoD the General Inspection Organization, Islamic Republic of Iran, on the issues of creation of an academy under the aegis of the AOA and establishment of an office of a cultural group in Iran, submitted a comprehensive working paper on the proposal elaborating the objectives, structure, services and the expenditure to be incurred. Since, the paper submitted by the General Inspection Organization, Islamic Republic of Iran was broad in nature, requiring further discussions to chalk out detail with respect to objectives, methodology, source of financing, implementing & over sighting mechanism, therefore, it was proposed by the AOA Secretariat, that a committee/working group consisting of members (two/three) of the BoD and officials of AOA Secretariat may be formed which may visit Tehran, on invitation of the General Inspection Organization, Islamic Republic of Iran, for further study, negotiations, drafting the TOR's and letter of agreement for consideration and approval of the BoD. The Board of Directors discussed the details of working paper and decided that new Board of Directors may further discuss the issue in its meeting and decides accordingly.

## **Decision:**

The Board of Directors deliberated upon the details of working paper prepared by the General Inspection Organization, Iran. It was decided to constitute a committee consisting of three members of the BoD and two members of AOA Secretariat which may visit Tehran, on invitation of the General Inspection Organization, Islamic Republic of Iran, for further study, negotiations, drafting the TOR's and letter of agreement for consideration and approval of the BoD. The committee will be headed by Professor Siracha Charoenpanij, Ombudsman of Thailand. The other members of the committee will be the representatives of the Office of the Ombudsman of Hong Kong and Administrative Evaluation Bureau, Japan. The committee will visit the General Inspection Organization, Islamic Republic of Iran at mutually agreed dates for a study and negotiations to help prepare a comprehensive report to be presented to the Board in the next Board meeting.

## Item No. 3

### **Use of AOA Funds**

(Carried over from 13<sup>th</sup> annual meeting of the B.O.D)

In its last Meeting held, on 5<sup>th</sup> December, 2011 the Board while considering and discussing the working paper prepared by the AOA Secretariat on objectives, methodology, source of financing, implementing & over sighting mechanism, for the program on utilization of AOA funds, decided that new Board of Directors may further discuss the issue in its meeting and decides accordingly.

- 2. While discussing on the issue Mr Alan Lai the Secretary AOA observed that:
  - AOA funds should be used on expenses relating to the instructors only.
  - Participants' expenses (e.g. flight and accommodation) should be borne by their respective countries.
  - The host country should be responsible for local hospitality (e.g. meals and entertainment.

## **Decision**

The Board agreed with the proposal of AOA Secretariat in principles. However it was decided that the AOA Secretariat will pursue the 2<sup>nd</sup> RETA Project with the Asian Development Bank (ADB). In case ADB agrees to finance the project then AOA funds will be made available for the activities not covered under the subject Project. Further, at the first instance efforts would be made to pursue the ADB to include non ADB AOA members in the project activities. If it would 1 not be possible then, the AOA funds may also be used to finance non ADB AOA members' activities to be carried out under the ADB project.

2. Position on the issue will be reviewed in the next Board meeting viz. a viz. the proposals of AOA Secretariat and observations of the Secretary.

The Meeting concluded with vote of thanks to the host his Excellency Mr. Hideo Arai, Director General and the Office of the Director General, Administrative Evaluation, Bureau, Japan
