# 12th General Assembly Meeting of the Asian Ombudsman Association (AOA)

### Date: 8<sup>th</sup> December, 2011, Venue: Numazu, Japan, List of participants is attached.

In his opening remarks, Ms. Conchita Carpio Morales, National Ombudsman, Philippines Vice President, Asian Ombudsman Association (AOA), welcome all members and in particular the new members who has recently joined the AOA and attending the General Assembly meeting for the first time. She also thanked Mr. Hideo Arai, Director General, Administrative Evaluation Bureau, Japan for the immaculate arrangements for the meeting. The Vice President highlighted the importance of this meeting in view of the fact that the members have to elect new Board of Directors. Thereafter, the agenda of the meeting as proposed by the Executive Secretary was taken up for discussion.

### Agenda Item No. 1

### Approval of the Audit Statements of the AOA accounts for the years 2009 & 2010.

The audit reports for the period from 1st January 2009 to 31st December, 2009 and 1st January, 2010 to 31st December, 2010 prepared by M/s AZ & Co. and WA Associates (Pvt.) Limited were placed before the Board of Directors during its 12<sup>th</sup> & 13<sup>th</sup> Annual Meetings held on 26<sup>th</sup> August, 2010 and 5<sup>th</sup> December, 2011 respectively. The Board approved the placement of the Audit Reports before the General Assembly.

#### **Decision:**

The General Assembly approved the audited accounts for the years 2009 & 2010. Resolution No.2 so adopted is placed at annex-I.

### Agenda Item No. 2

### Consideration of proposal for hosting the 13<sup>th</sup> AOA Conference in 2013.

On invitation of proposals to host 13<sup>th</sup> Conference of the AOA in 2013, by the AOA Secretariat the General Inspection Organization, Islamic Republic of Iran, has offered to host the 13<sup>th</sup> AOA conference in Tehran, Islamic Republic of Iran. The Board of Directors while

supporting the proposal, recommended to the General Assembly to accept the offer of the General Inspection Organization, Islamic Republic of Iran.

### Decision

The General Assembly unanimously approved the Board's recommendation to host the 13<sup>th</sup> AOA Conference in Tehran, Iran.

Resolution No.2 so adopted is placed at annex-II

### Agenda Item No. 3

### Elections of the office holders and members of the Board of Directors of the AOA.

During the 10<sup>th</sup> meeting of the General Assembly held on 2007 at Hanoi Vietnam, elections of the Board were held. The terms of office holders and members were expiring, hence new elections were required.

2. Accordingly, in terms of Clause II Sub-Clause 2-1 and 2-2 of the Code of Conduct of the Association, the nominations for all offices on the Board were invited. The position was as follows;-

- a. No nomination for the post of President was received. Under clause 9(1) of the Bye Laws of AOA, the Board of Directors in its meeting held on 4<sup>th</sup> December 2011, vide Resolution, No. 1 of BoD had been pleased to resolve that;-
  - " (a) if the Wafaqi Mohtasib (Federal Ombudsman) of Pakistan is appointed by 31 May 2012, he or she shall be invited to be the President of AOA; and
    - (b) if no person is appointed to the post of Wafaqi Mohtasib (Federal Ombudsman) Pakistan by 31 May 2012, or if the Wafaqi Mohtasib declines the invitation, the Board of Directors shall determine how the post of the President of AOA is filled."

The resolution adopted by the Board of Directors was placed before the General Assembly for consideration and ratification.

b. Only one nomination of Ms. Conchita C. Morales i.e., the Ombudsman of Philippines was received against the post of the Vice President. She had been pleased to withdraw her nomination to serve as Vice President, on account of her official commitments at home. Subsequently, Dr. Fong Man Chong, Commissioner for Commission Against Corruption, Macao, SAR China nominated Mrs. Panit Nitithanprapas, the Chief Ombudsman of Thailand, for the post of Vice President for the term commencing 8th Dec, 2011. The nomination was seconded by Mr.Danang Grindrawardana, the Ombudsman of Indonesia.

Accordingly, under clause 9(1) of the Bye Laws of the AOA, the nomination of Mrs. Panit Nitithanprapas, was placed before the General Assembly for consideration and approval.

- c. Only one nomination was received for the post of Secretary ie.
  Mr. Alan Lai, the Ombudsman of Hong Kong. He, therefore he stood elected unopposed.
- d. Only one nomination was received for the post of Treasurer i.e. Ms. Kim Young-ran, Chairperson Anti-Corruption & Civil Rights Commission, Republic of Korea. She, therefore, stood elected unopposed.
- e. After accepting the nomination by Mrs. Panit Nitithanprapas, the Chief Ombudsman of Thailand for the post of Vice President, there were only five candidates against five posts of the members of the Board of Directors, i.e.
  - Ms. Ma Wen, Minister, Ministry of Supervision, Peoples Republic of China.
  - 2. Mr. Hiedo Arai, Director General, Administrative Evaluation Bureau, Japan
  - Justce Pour Muhammadi, Government Inspection Organization, Islamic republic of Iran.
     Dr. Fong Man Chong,
  - Commissioner for Commission Against Corruption, Macao, SAR, China,
  - 5. Dr. Tam Weng Wah, Director General, Public Complaints Bureau, Malaysia.

Consequently, the above mentioned candidates stood elected as member of the Board of Directors. The General Assembly was requested to approve accordingly.

2. As the Vice President placed the Resolution passed by the Board of Directors, before the General Assembly for ratification, inviting the Wafaqi Mohtasib for the Presidentship of the AOA, Mr. Shoaib Suddle, Federal Tax Ombudsman, on point of order raised an objection saying that there is discrimination in the voting rights of the full members of the Association. Voting rights of the full members admitted from one country has been restricted to the founding members or to the Ombudsman enjoying the status of National/ Federal Ombudsman. He stressed that voting rights of other full members from the same country should be brought at par. He also questioned whether the next term of the AOA Presidentship was offered to Pakistan or specifically to the Federal Ombudsman of Pakistan. In case the offer was for Pakistan then the choice of nominating the candidate for Presidentship is left to the Forum of Pakistan Ombudsman (FPO), a forum representing all Ombudsmen Federal and Provincial Ombudsmen in the country.

3. Replying to the above raised objection/suggestion the Secretary AOA (Mr. Alan N. LAI) explained the General Assembly that suggestion put forward by the honourable members needs amendment in the Bye-Laws of the Association that entails necessary process described in the Bye-Laws and Code of Conduct of Business of the Association. Therefore, General Assembly is not in a position to deviate from the standard prescribed procedure. He informed the General Assembly that the proposal submitted by the honourable member will be processed in accordance with law.

4. The Executive Secretary explained to the honourable member that the Board of Directors were pleased to extend the offer for Presidentship for the next term to the Federal Ombudsman of Pakistan, considering the service rendered by the office of the Wafaqi Mohtasib and AOA Secretariat being housed and operated in the office of Wafaqi Mohtasib. He informed the house that the resolution passed by the Board is placed for ratification or otherwise.

#### **Decision:**

The Chairperson placed the Resolution adopted by the BoD and recommending to the General Assembly for ratification regarding nomination of Federal Ombudsman of Pakistan as President AOA before the house, which carried with majority votes. Resolution No. 3 adopted by the General Assembly is at Annex-III.

2. Other Motion tabled by Federal Tax Ombudsman Pakistan before the General Assembly for adoption, allowing one institution one vote right, for consideration under Bye Law 9(1) of the Bye Laws of the AOA while suspending Clause III of the Code of Conduct was not carried by the house and rejected. Only one vote was casted in favor of the Resolution. However, it was decided that the motion/proposal moved by Federal Tax

Ombudsman Pakistan will be processed by the AOA Secretariat as provided in the Bye- Laws and Code of Conduct of Business of AOA.

3. The nomination of Mrs. Panit Nitithanprapas, Chief Ombudsman- Thailand, placed before the General Assembly for consideration and approval, under clause 9(1) of the Bye Laws of the AOA, was approved. So she stood elected unopposed.

4. Since only one nomination was received against each post of Secretary i.e. Mr. Alan Lai, the Ombudsman of Hong Kong and Treasurer i.e. Ms. Kim Young-ran, Chairperson Anti-Corruption & Civil Rights Commission, Republic of Korea, therefore, both stood elected unopposed.

5. After election of Mrs. Panit Nitithanprapas, the Chief Ombudsman of Thailand as the Vice President, there were only five candidates against five posts of the members of the Board of Directors, i.e.

- Ms. Ma Wen, Minister, Ministry of Supervision, Peoples Republic of China.
- 2. Mr. Hiedo Arai, Director General, Administrative Evaluation Bureau, Japan
- 3. Justce Pour Muhammadi Government Inspection Organization, Islamic republic of Iran.
- 4. Dr. Fong Man Chong, Commissioner for Commission Against Corruption, Macao, SAR
- 5. Dr. Tam Weng Wah, Director General, Public Complaints Bureau, Malaysia.

Consequently, the above mentioned candidates stand elected as member of the Board of Directors. Accordingly Resolution No.4 of 2011 adopted by the General Assembly declaring the results of the election of the office bearers and members of the Board of Directories is placed at annex-IV.

### Approval of resolution for membership of the AOA for the following applicants:

The Office of the Lok Ayukta (Ombudsman), Government of National Capital Territory of Delhi, India, the Lok Ayukta (Ombudsman), Andhra Pradesh, India, the Commissioner for Human Rights (Ombudsman) Republic of Azerbaijan, office of the Ombudsman (Provedoria) for Human Rights and Justice, Democratic Republic of Timor-Leste and the Commissioner for Human Rights, Republic of Tatarstan had applied for Full Memberships of the Association.

2 The Board of Directors in its meetings held on 26<sup>th</sup> August 2010 and 5<sup>th</sup> December 2011 examined and recommended their membership applications as they found eligible in the light of Bye-Law 5(1) and Article I of the Code of Conduct of Business of the Association for full membership. It was recommended to the General Assembly to accept the membership applications of the Lok Ayukta (Ombudsman), Government of National Capital Territory of Delhi, India, the Lok Ayukta (Ombudsman), Andhra Pradesh, India, the Commissioner for Human Rights (Ombudsman) Republic of Azerbaijan, office of the Ombudsman (Provedoria) for Human Rights and Justice, Democratic Republic of Timor-Leste and the Commissioner for Human Rights, Republic of Tatarstan had applied for Full Membership of the AOA.

### **Decision:**

The General Assembly unanimously ratified the Board's recommendations for awarding Full Membership to the Lok Ayukta (Ombudsman), Government of National Capital Territory of Delhi, India, the Lok Ayukta (Ombudsman), Andhra Pradesh, India, The Commissioner for Human Rights (Ombudsman) Republic of Azerbaijan, office of the Ombudsman (Provedoria) for Human Rights and Justice, Democratic Republic of Timor-Leste and the Commissioner for Human Rights, Republic of Tatarstan.

Resolution No.5 of 2011 as adopted is at annex-V.
